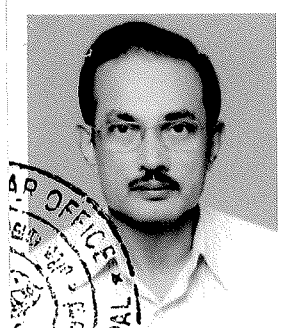

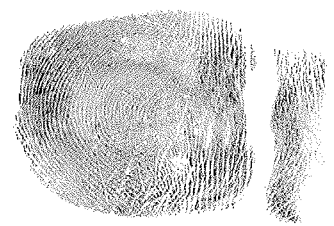

Whereas Rev. Fr. George Koodathil, son of late John, the then Vicar St. Mary's Forane Church residing at Parsonage in Kudamaloor, Kudamaloor Kara, Aymanam Village, Kottayam Taluk, Kottayam District, as the Settler and with other six members constituted and registered a trust under the name and style **"ST. Mary's Forane Church Educational and Charitable Trust Kudamaloor"** (PAN - AALTS 4301B) with its registered office at Parish House, No. 249 in Ward 8 of Aymanam Gramapanchayath, Kudamaloor P O, Pin 686017, registered as No. 37 of 2011 in Book IV, Volume 314 on Pages from 89 to 92 at the Kottayam Sub Registry having a corpus fund of Rs. 1,000/- drawn on Stamp papers worth Rs.1000/-

Whereas the above said trust deed suffers certain deficiencies in the absence of the clauses appearing hereafter.

Whereas the board of Trustees of **"ST. Mary's Forane Church Educational and Charitable Trust Kudamaloor"** for the time being in the meeting on 27<sup>th</sup> July 2024 have resolved to add the following clauses in the deed of Trust described above.

After clause 21(6), the following mandatory clauses shall be added;

22.i. The objects/activities of the trust shall be carried out only in India.

- ii. Any amendment to the existing registered Trust Deed will be carried out only with the prior approval of the commissioner of income tax having jurisdiction.
- iii. In the event of dissolution/winding of the trust the assets remaining as on the date of dissolution shall, under no circumstances, be distributed among the Trustees/members of the Managing Committee/Governing Body but the same shall be transferred to another Charitable Trust/Society whose objects are similar to those of this Trust and which is registered u/s 12 A/ 12AB of Income Tax Act 1961 at the time of transfer or shall be vested with the Government.
- iv. If powers to effect amendment to the Trust deed / Memorandum of Association /byelaws have been given the Trustees / office bearers, it would not be extended to altering the basic character of the trust and further, no such amendments which may prove to be repugnant to the provisions of section 2 (15), 11, 12, 13 and 80 G of the Income tax Act, shall be made.
- v. The accounts of the trust shall be regularly maintained and every year, the accounts shall be closed by 31<sup>st</sup> March and the same shall be audited by a qualified chartered accountant.
- vi. The income and the funds of the trust will solely be utilized for the objects and no portion of it will be utilized for payment to the Trustees/ members/ office bearers by way of profit/ dividend/ interest etc.
- vii. The benefit of the trust is open to all, irrespective of caste, religion, creed, gender etc.


